- The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per appendix III issued by District Education Officer (DEO) /equivalent officer.
- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.
- The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there of for reference purpose and also advised to visit CBSE websites i.e. <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates. The School is expected to see all circulars on these CBSE websites regularly.

\* As reported by the I C member the Pucca Boundary Wall of sufficient height on all sides does not exist. Elaborate. The side of the school play ground has been covered with Aluminium wire mesh grill and one area with aluminium roofing sheet. As per the affiliation bye laws all the sides should be surrounded by a pucca boundary wall with sufficient and adequate height. Therefore, the school is directed to make pucca boundary wall on all the sides of the school campus and submit the compliance with evidence.

\* The school is required to submit the details of the area of the campus of previous affiliation/upgradation/subsequent extension. If there is any variation in area of the campus, then school is required to submit its clarification in the matter. The school is required to comply the previous grant conditions if any, imposed by the Board on school at the time of precious grant of affiliation.
